CSAA Update:

They are working with the school in Hays. Tina has the presentation on email. They are looking at a standardized reporting form for LACs.

Agency/Provider Update:

Youth Dynamics Linda Bragg reported they are serving Fort Belknap to Chester to Rocky Boy. ASIST Suicide Prevention Class is a good one, taught by Jackie Fitzgerald of Voices of Hope. Linda informed the group that the Hays area is served by the Malta YDI.

LeAnn reported that the Sweet Medical Center had a small committee at the clinic working on mental health. There are some resources thought Tele-med. Mental Health America is a resource also the Montana contact person is Dan. The new provider is interested in Mental Health.

Ben with the Center for Mental Health reported that he and Jay are putting on a co-occurring group. It is every Thursday from 1:30 to 2:45 in Havre. He will be in Chinook every Wednesday. They are always looking for the areas of need with in the county to assist in providing those resources and or services. Two areas of need were identified. Harlem is in need of school based services if they can possible help out there it would be good. The Turner school is also looking at some Adult Ed classes and that may be a place to help also.

Tina reported that Dr. Epperson with IHS is located at Hays most of the time. She was looking for additional resources and options for services. Tina gave her both YDI and Center for Mental Health contact names and numbers.

Mental Health First Aid:

Terry is going to talk to Toby about putting on an adult ed class in Turner. Also see what his interest is in being a trainer for other classes held in the county. Ben is going to ask the trainers in Havre if they are interested in doing some training in Blaine County. Jan can provide the books for free. She could do the training but would like to see us use locals.

Public Health, Jana reported the health assessment is ongoing. Will continue to keep us posted.
